

Continuing Education (CE) Credit Instructions for Attendees

COURSE COMPLETION REQUIREMENTS AND CE INFORMATION: Participants must attend the entire 2 hour program. Partial credit is not awarded.

Participants must also complete the entire CE process online, before the **CE deadline of March 1, 2022.**

CE instructions for attendees are as follows:

1. Go to <https://educate.hospicefoundation.org> and create an account, if you don't have one already
2. Enter the Course Code (*provided at the end of the program*)
3. Enter the Site ID **40051**
4. Complete the exam. The exam must be completed at 80% or above to pass (the exam may be re-taken, if necessary)
5. Choose the board from which they wish to receive credit
6. Fill out the evaluation form
7. Print or email your CE certificate immediately
8. "Sign in" to verify your virtual attendance by emailing your name, the date you viewed the program and Site ID 40051 to mccauley@oregonhospice.org.
